

# Jennie and Arthur Loo First in Family Scholarship

## Description

The Scholarship was established in 2020 and is funded by Waipapa Taumata Rau, University of Auckland alumnus Arthur Loo and his wife Jennie.

The main purpose of the Scholarship is to assist students enrolling in the first year of a degree in Architectural Studies, Design, Engineering, Medical and Health Sciences or Science, who are the first member of their immediate family to attend university and who, because of financial hardship, may not otherwise be able to undertake a university degree.

## Selection process

- Application is made to the Scholarships Office
- A Selection Committee assesses the applications
- Short-listed applicants may be required to attend an interview
- The Scholarship is awarded by the University of Auckland Council on the recommendation of the Selection Committee

## Regulations

1. The Scholarship will be known as the Jennie and Arthur Loo First in Family Scholarship.
2. One Scholarship will be awarded every three to four years, for a period of up to four years, and will be of the value of up to \$8,000 per annum (see Note I).
3. To be eligible for consideration for the Scholarship applicants must be i) a citizen or permanent resident of New Zealand, ii) the first member of their family to attend university (see Note II), iii) currently enrolled in their final year at a New Zealand secondary school or kura, and iv) intending to enrol full-time in the first year of their first undergraduate degree, an undergraduate degree or conjoint degree in either the Faculty of Engineering, the Faculty of Medical and Health Sciences, or the Faculty of Science, or in a Bachelor of Architectural Studies or Bachelor of

Design or associated conjoint degree in the Faculty of Creative Arts and Industries, at Waipapa Taumata Rau, University of Auckland.

4. The basis of selection will be academic merit based on results at Level 2 or higher in the National Certificate of Educational Achievement (NCEA) or an equivalent qualification, the applicant's motivation to succeed at university and demonstrated financial hardship as assessed by a personal statement and the criteria at Note III, and performance in an interview. Consideration may be given to students who attended a state secondary school. Short-listed applications may be required to attend an interview (see Note IV).
5. The Scholarship will be awarded by the University of Auckland Council on the recommendation of a Selection Committee comprising the Pro Vice-Chancellor (Equity) (or nominee), the Chair of the Scholarships Committee (or nominee), a representative of the Alumni Relations and Development Department and a representative of the Donors.
6. The Scholarship will be paid each year in two equal instalments in Semester One and Two, as soon as is practical after confirmation of enrolment (that is, after the final date on which a student may add or delete courses without incurring a late enrolment fee).
7. To be paid the Scholarship, the awardee must i) have achieved admission to Waipapa Taumata Rau, University of Auckland and ii) be enrolled in either an undergraduate degree or conjoint degree in the Faculty of Engineering, the Faculty of Medical and Health Sciences, or the Faculty of Science, or a Bachelor of Architectural Studies or Bachelor of Design or associated conjoint degree in the Faculty of Creative Arts and Industries, at Waipapa Taumata Rau, University of Auckland. To be paid the second and subsequent instalments, the awardee must i) remain enrolled in an eligible programme, and ii) have achieved a grade point average (GPA) of at least 5.00 (equivalent to a B average) in each semester of study (see Note V).
8. The Scholarship may not be held concurrently with any scholarship funded by Waipapa Taumata Rau, University of Auckland excluding a Tier 2 or 3 University of Auckland Academic Potential Scholarship. However, it may be held with any other scholarship, award or grant as long as the regulations for that scholarship, award or grant permit and the University of Auckland Council is informed and approves. It is the responsibility of the awardee to declare to the Scholarships Office all other scholarships, awards or grant funding received and for which the awardee receives payment while also in payment for this Scholarship.
9. The University of Auckland Council, in consultation with the Donors, has the power to terminate or suspend a scholarship if it receives a report of unsatisfactory progress of a Scholar from the Head of Department or School in which the recipient is enrolled.
10. The University of Auckland Council is not obliged to make an award if it is determined there is no candidate that meets the criteria and/or no candidate of sufficient merit.
11. The University of Auckland Council, in consultation with the Donors, can amend or vary these regulations provided that there is no departure from the main purpose of the Scholarship.
12. Applications close with the Scholarships Office on TBC.
13. Notes [I]-[VII] below are deemed to be Regulations.

## Notes

---

- I. *The Scholarship will cover up to four years of a first undergraduate degree (including a conjoint degree). The Scholarship may be extended to include further funding for postgraduate study, subject to an application in writing to the Scholarships Office at the completion of the undergraduate degree.*
- II. *For the purpose of this scholarship, 'first in family' to attend university means the first member in their family, including parents and siblings, to enrol at a university. Adoptive and step parents and siblings are considered part of the nuclear family where they have lived with the applicant for the previous five or more years.*
- III. *Financial need will be determined by a range of factors including eligibility for a StudyLink Student Allowance, and personal and financial circumstances. Candidates need to demonstrate that they are experiencing financial hardship and that they are struggling to meet basic living costs. Incurred debt is not evidence of financial hardship.*
- IV. *Interviews may take place via video conference.*

- V. *For the purposes of this Scholarship, the recipient's grade point average (GPA) is based on all the courses they undertake in each semester of study.*
- VI. *Payments under the terms of this Scholarship remain tax-free as long as they are used directly for the payment of costs associated with an awardee's programme of study and/or to assist the awardee with living costs while studying. Failure to comply with this regulation will result in the termination of the Scholarship.*
- VII. *Awardees will be required to comply with the regulations for the Scholarship and must notify the Scholarships Office of any change in their enrolment or funding status. Waipapa Taumata Rau, University of Auckland may, in the event that it can be established that an awardee is not complying with these regulations, terminate the Scholarship and require repayment of the funds received from the date of the breach.*
