

# Jeremy Howard Scholarship

## Description

This Scholarship has been set up by the family and friends of Jeremy Howard who, after graduating from the University in 2002, took up a career with Stedman Blower Architects in England. Tragically Jeremy's promising career was cut short by his sudden death in late 2003. This Scholarship has been set up to celebrate his many talents and achievements during his shortened life.

## Selection process

- Application is made to the Scholarships Office
- A Selection Committee assesses the applications
- The Scholarship is awarded by the University of Auckland Council on the recommendation of the Selection Committee

## Regulations

1. The Scholarship shall be known as the Jeremy Howard Scholarship.
2. One Scholarship will be awarded annually and will be of the value of up to \$5,000.
3. To be eligible Scholarship consideration, an applicant must be i) a New Zealand Citizen or Permanent Resident, ii) enrolled in either Year Two or Year Three of a Bachelor of Architectural Studies (BAS) or Year One of a Master of Architecture (Professional) (MArch(Prof)), and iii) be enrolled, or intending to enrol, for one or two semesters in an undergraduate or postgraduate architectural programme at a university in the United Kingdom as part of a 360 International exchange programme (see Note II).
4. The basis of selection will be academic merit as assessed by the applicant's cumulative grade point average. Consideration may be given to students intending to enrol at Kingston University, London.
5. The Scholarship will be awarded by the University of Auckland Council on the recommendation of a Selection Committee comprising the Dean of the Faculty of Creative Arts and Industries (or nominee), the Head of the School of Architecture and Planning (or nominee) and one representative of the Donor (appointed by sponsors or trustees).
6. The Scholarship will be paid in one instalment subject to confirmation of enrolment at the chosen University.

7. The Scholarship may be held concurrently with any other scholarship, award or grant as long as the regulations for that scholarship, award or grant permit and the University of Auckland Council is informed and approves. It is the responsibility of the awardee to declare to the Scholarships Office all other scholarships, awards or grant funding received and for which the awardee receives payment while also in payment for this Scholarship
8. The University of Auckland Council is not obliged to make an award if it is determined there is no candidate that meets the criteria and/or no candidate of sufficient merit.
9. The University of Auckland Council can amend or vary these Regulations (in consultation with the Donor) provided that there is no departure from the main purpose of the Scholarship.
10. Applications close with the Scholarships Office on 15 June in the year of the award.
11. Notes [I]-[VI] below are deemed to be regulations.

## Notes

---

- I. The tax-free status of this Scholarship is under current legislation. The University of Auckland cannot guarantee this tax-free outcome.*
- II. Students may only apply to go on a 360 International exchange programme in Semester Two of Year Two, or Semester One of Year Three of the BAS degree, or Semester Two of Year One of the MArch(Prof) degree.*
- III. Refer to the 360 International exchange programme website for details of how to apply and eligibility for exchange. A minimum cumulative GPA of 5.00, inclusive of current and past enrolment, is required for consideration for the exchange programme.*
- IV. In the event that the awardee decides to withdraw from the exchange programme at any point after receiving the Scholarship payment, the full amount of the Scholarship must be repaid. In the event that the awardee is unable to travel overseas, and the exchange is completed online from New Zealand, the full amount of the Award, less any unrecoverable costs not covered by travel insurance, must be repaid.*
- V. Payments under the terms of this Scholarship remain tax-free as long as they are used for the payment of costs associated with an awardee's programme of study and/or to assist the awardee with living costs while studying. Failure to comply with this regulation will result in the termination of the Scholarship.*
- VI. Awardees will be required to comply with the regulations for the Scholarship and must notify the Scholarships Office of any change in their enrolment or funding status. Waipapa Taumata Rau | University of Auckland may, in the event that it can be established that an awardee is not complying with these regulations, terminate the Scholarship and require repayment of the funds received.*
