# THE UNIVERSITY OF AUCKLAND POLICY ON SPECIAL CONDITIONS FOR WRITTEN TESTS AND EXAMINATIONS



#### **1.0 PURPOSE**

This policy outlines the framework established by The University of Auckland for the approval of special conditions in written tests and examinations for students with impairments.

## 2.0 POLICY

The University of Auckland will provide appropriate special conditions to students with a permanent or temporary impairment, for written tests sat under exam conditions and examinations. Students are required to apply to the University for special conditions. Applications are made through one of two approved service providers — University Health Services for students with medical impairments or the Learning Disabilities team within Student Learning Services for students with learning impairments.

All applications must be supported by evidence from an appropriately qualified professional. The approved conditions are to be determined in accordance with guidelines established by the respective University service provider. Special conditions may therefore vary from those previously approved at other institutions or recommended by external practitioners.

Special conditions may be granted for a defined length of time or on a permanent basis depending on the nature of the impairment and the evidence provided.

Application for the approval of on-going special conditions for a permanent impairment must be made to the appropriate service provider no later than the second Friday following the commencement of lectures. Applications for temporary conditions must be made to the appropriate service provider as soon as possible.

#### **DEFINITIONS**

Approved by: Council

Approved special conditions may include, depending on resource availability and assessment content:

- Extra time for rest breaks
- Additional writing time
- Access to a reader and/or writer
- Access to a stand-alone computer, without internet or network connectivity
- Examination venue with fewer or no other students present.
