# LAW 400 and 499 Guidelines for 2016

#### Completion of LAW 400 or LAW 499 is one of the compulsory requirements to complete your LLB/LLB(Hons) degree

Students enrol in LAW 400/499 <u>only in the final semester</u> of their degree, when they are completing their LLB (or LLB(Hons) exclusive of the dissertation) requirements. A DNC will be recorded if LAW 400/499 is incomplete at the end of two semesters after the enrolment (excluding Summer School) e.g. If you enrol in LAW 400/499 in First Semester 2015 and still have not completed by the end of First Semester 2016 a DNC will be recorded and you will need to reenrol.

# LAW 400 – Legal Research 3 (10 points) requirements in 2016

## 2016 is the last year that LAW 400 will be available


You need to complete the compulsory Part III Moot (General, Family, Maori Issues or Pacific Islands) and pass 5 opinions (with at least 3 plussage opinions in 10, 15 or 20-point elective courses that have a final examination or take-home examination)

## **Maximum 2** opinion credits (**Alternatives**) can be obtained from:

- i. Completion of one Community Placement
- ii. A pass in at least 3,000-word assignment/essay in an internally-assessed course (10, 15 or 20-point courses)
  - \*provided you complete all assignments in the course
- iii. A pass in Paper in lieu of exams (PILO)
- iv. A pass in Supervised Research paper (LAW 456)
- v. A pass in a subject related moot (e.g. in Employment Law)

#### **CHANGE TO REQUIREMENTS IN 2016**

Owing to the change in assessment for all elective courses in 2016 and the dearth of 3000-word written assignments, we will accept as a 'plussage opinion' any single piece of writing (other than a take-home exam or a take-home test) of at least 1500 words in an elective course. You must complete all the other requirements of the course, and pass the elective, to receive the credit.

Please note that only one opinion credit is available from each elective course. Where there is more than one written assignment of 1500 (or more) words in an elective course, only the first assignment will be credited.

#### The following do **NOT** qualify for an opinion credit towards LAW 400:

- a) AULR editorial work or other roles
- b) EJP
- c) Model UN, World Client Interviewing and other competitions
- d) Honours seminar papers and dissertations although may count in special circumstances where student has discontinued Honours and has approval from AD(Academic).
- e) External or international mooting competitions (incl. Greg Everard)

## LAW 499 – Legal Practice (0 points) requirements in 2016:

You need to complete the compulsory Part III Moot (General, Family, Maori Issues or Pacific Islands) and pass 5 single pieces of legal writing of at least 3,000 words in law elective courses.

### A single piece of legal writing of at least 3,000 words may include:

- An opinion in 10, 15 and 20-point law elective courses
- A single piece of legal research and writing of at least 3,000 words for an internally-assessed elective course \*provided you complete all assignments in the course
- A research paper in lieu of exams (PILO) \*
- A Supervised Research paper (LAW 456)

At least 3 single pieces of legal writing need to be completed. The other 2 single pieces of legal writing can be substituted by the following alternatives:

- Community Placement
- One subject-related or competitive moot (incl. Stout Shield)
- Two subject-related or competitive moots (incl. Stout Shield) if no Community Placement has been counted

### The following do NOT qualify for an opinion credit towards LAW 499:

- a) AULR editorial work or other roles
- b) EJP
- c) Model UN, World Client Interviewing and other competitions
- d) Honours seminar papers and dissertations (although may count in special circumstances where student has discontinued Honours and has approval from AD(Academic)).



<sup>\*</sup>Where a PILO and opinion are completed in the same course both may be credited toward LAW 499 provided they are on different topics, and subject to other guidelines.

#### These are the 5 options in completing LAW 499:

**Option 1:** Part III Moot completion and

A pass in each of 5 single pieces of legal writing of at least 3,000 words in law elective courses

Option 2: Part III Moot completion and

A pass in each of 4 single pieces of legal writing of at least 3,000 words in law elective courses and

**Community Placement** 

Option 3: Part III Moot completion and

A pass in each of 4 single pieces of legal writing of at least 3,000 words in law elective courses and

A subject or competitive moot

Option 4: Part III Moot completion and

A pass in each of 3 single pieces of legal writing of at least 3,000 words in law elective courses and

Community Placement and A subject or competitive moot

**Option 5:** Part III Moot completion and

A pass in each of 3 single pieces of legal writing of at least 3,000 words in law elective courses and


2 subject or competitive moots

#### **CHANGE TO REQUIREMENTS IN 2016**

Owing to the change in assessment for all elective courses in 2016 and the dearth of 3000-word written assignments, we will accept as a 'single piece of writing of at least 3000 words' any single piece of writing (other than a take-home exam or a take-home test) of at least 1500 words in an elective course. You must complete all the other requirements of the course, and pass the elective, to receive the credit.

Please note that only one opinion credit is available from each elective course. Where there is more than one written assignment of 1500 (or more) words in an elective course, only the first assignment will be credited.
